Notice regarding Dividends from Surplus (Dividend Increase)

TIS Inc. (hereafter, “TIS” and “the Company”) hereby announces that the Board of Directors resolved at its meeting today to distribute dividends from surplus, with a record date of March 31, 2026. Details are provided below.

Note that this resolution will be referred for discussion and approval at the 18th Annual General Meeting of Shareholders scheduled for June 23, 2026.

2. Reasons

The Company’s basic policy is to keep internal reserves at a level sufficient to ensure business growth from a medium- to long-term perspective, while continuing to pay a stable dividend in consideration of consolidated financial results.

Guided by this policy, TIS endeavored to build a more appropriate capital structure and improve capital efficiency during Medium-Term Management Plan (2024–2026), underpinned by a good balance in its approaches to promote growth investments and ensure a sound financial position. In the process, the Company had a goal to raise the level of engagement with all shareholders by boosting the total return ratio yardstick to 50%, from 45%, and constantly enrich dividends per share. In addition, TIS seeks to constantly enrich profit distribution to shareholders, matched to business growth, and toward this end, management feels it is best to implement return to shareholders based

on profit obtained from operating activities not impacted by temporary profits and losses.

Management plans to distribute a year-end dividend of ¥42 per share for fiscal 2026, ended March 31, 2026, which is ¥4 higher than first announced. This reflects favorable business growth that performance results exceeded initial estimates. Consequently, the annual dividend for fiscal 2026 will be ¥80 per share. Adding in the repurchase of 12,778,800 shares of treasury stock, for ¥55,925 million, the total return ratio will reach 158.5%. Note that, as described above, when excluding the repurchases of treasury stock conducted for purposes such as optimizing the capital structure, the total return ratio derived on this criteria is 49.0%—a level in line with basic policy.
